

**ETHICS BOARD MEETING
MINUTES OF THE PUBLIC SESSION**

The Ethics Board (“Board”) met on Wednesday, November 12th, 2025 at 2:30pm by conference call via Microsoft Teams.

Call to Order & Statement Concerning the Recording of the Public Session: Chair Fogleman called the Board meeting to order at 2:33pm with All Board members, a quorum, present. No members were absent

Chair Fogleman read the following statement:

All participants in the Public Session of the Board meeting acknowledge and consent to the video and audio recording of the Public Session and the publication of the recording on the Board’s website and social media accounts.

Statement Concerning the Administrative Session of the October 12th, 2025 Board Meeting: Chair Fogleman read the following statement:

Per the Open Meetings Act, the Board discloses that it adjourned its virtual open meeting on October 12th 2025 to enter the Administrative Session at approximately 3:20 pm. Three Board members were present. Member Noelle Newman was absent. Members discussed administrative matters including complaints.

Likewise, upon adjournment of the Open Session, the Board may reconvene for an Administrative Session to discuss non-public, administrative functions of the Board.

* Dir. Amberger provided an update on the ethics requirement training courses that’s held for newly hired employees. New employees receive in-person instruction regarding the Ethics obligations during monthly meetings.

* The Board has reminded petitioners for gift solicitation waivers that the application must first be approved by the Board of Estimates before it can be presented to the Ethics Board
